

# On 1 John 1:7 (Forgiveness)

There is considerable misunderstanding about automatic forgiveness of sin. Some seem to have the mistaken idea that Jehovah God, by the sheer exercise of his unqualified grace, will wipe out "secret sins."

The notion that the Creator ignores innocent-looking wickedness by the operation of his unlimited mercy takes various twists. A few say that all men walk under the protection of boundless grace and therefore no one will be lost—not even Adolph Hitler and Charles Manson.

Others claim that it is impossible for any man to know and do all that God requires of him. Hairsplitting arguments attempt to show that if a person does not fully understand niceties of divine injunctions, his ignorance or transgression or omission will be spontaneously dismissed.

Advocates of the idea of grace dispensing with some law are unwilling or unable to name specific sins that God "winks at" in our age. Still, they cannot bring themselves to believe that God will enforce his laws absolutely. They fear lest some tender soul might be tortured with nameless guilt and beset with nightmares and look for some basis to say to the transgressor that God will impulsively forgive, and grant the sinner peace and rest.

The one verse to which all advocates of automatic forgiveness appeal is this:

"If we walk in the light, as he is in the light, we have fellowship one with another, and the blood of Jesus his Son cleanseth us from all sin" (1 John 1:7).

Though we had a lengthy discussion on this around the first of this year, I will again consider the question because a few dear brothers are still having trouble grasping John's teaching—they don't seem to catch his drift, as the dudes say. Certain nervous-nelly types wring their hands and clutch their chests and bemoan the poor soul that violates some obscure and petty rule in the divine lawbook.

Shall such a one go down to eternal perdition simply because he/she was caught on some technicality? Thinking about someone floundering forever in flames of fire because of being entrapped on the hook of some minor point of doctrine is more than they can bear. Surely, they think, we can stretch the strait gate just a little—just enough to take care of insignificant violations.

There are several things amiss in this wrong-headed thinking. In the first place, it casts doubt on God's love and goodness and suggests that the Lord makes loopholes in his law and plays games with us (it does seem God is wise enough to speak to us in our language so we can understand him). The laws of God are not all that complicated. Any person who wants to do the will of God can understand his will (John 7:17).

In the second place, it denies God's holiness and purity and suggests that, after all, God ought to tolerate some sins — *teeny-weeny ones* —(mortal sins deserve hell, but venial sins should be purged in some temporary confinement, or entirely overlooked, according to this view).

In the third place, it does not take into account the justice of God. God is love, but he is also just. His mercy tempers judgment, but according to rule and not by whim. "Behold then the goodness and severity of God: toward them that fell, severity; but toward thee, God's goodness, if thou continue in his goodness: otherwise thou also shalt be cut off' (Rom. 11:22).

In the fourth place, it assumes superior knowledge about what is minor and unimportant and about what is major and necessary. If you keep the whole law but offend in one point—even if you think it is a tacky point—you have violated the whole law (James 2:10). The essence of sin—even so-called small sins—is rebellion. If we rebel in one point, we will rebel in another because we have an indisposition to respect the law. There may be large and small consequences of law-breaking, but all infractions are equally serious. Otherwise God is a respecter of persons. We must understand what it means to walk in the light. The condition upon which the blood of the lamb is cleansing us from all sin is walking in the light, according to 1 John 1:7. Please don't forget the condition—the passage begins with an “if”—“if’ we walk in the light, then—and only then—does the blood of Jesus keep us clean from all sin. If we do not walk in the light, then the cleansing does not follow.

Walking in darkness is the opposite of walking in light. Either we walk in darkness or we walk in light, and we cannot do both simultaneously.

*Note:* “If we say that we have fellowship with him and walk in the darkness, we lie, and do not the truth” (1 John 1:6).

*Note:* “He that saith, I know him, and keepeth not his commandments, is a liar, and the truth is not in him” (1 John 2:3).

He who walks in darkness and says he knows God lies (1 John 1:6).

He who keeps not God's commandments and says he knows God lies (1 John 2:4).

Therefore walking in darkness is the same as not keeping God's commandments.

If the negative is true, the positive is also true. Walking in

darkness is not to keep his commandments. Walking in light is keeping his commandments. Therefore, John is saying if we keep the commandments of God the blood of Jesus keeps us clean from all sin.

*Question:* How can a person sin who is walking in the light—keeping God’s commandments? *Answer:* One who attempts to hear and do the words of Jesus can fail—he may omit to do something the Lord requires of him or do something the Lord forbids. If he should sin, he repents and confesses; that constitutes walking in the light—keeping God’s commands—and the blood of the lamb is cleansing him from all sin. If a blood-bought child of God sins but excuses his wrong and will not confess and repent, he is not walking in the light and the blood will not cleanse his transgressions. The key is walking in the light. Walking in the light is a continuous action. Cleansing therefore is a continuous action because walking in the light involves keeping the commands of God, which involves confessing sin and repenting of sin. All of this—walking in the light, confessing, repenting, and cleansing—is continuous action.

“If we confess our sins, he is faithful and righteous to forgive us our sins, and to cleanse us from all unrighteousness” (1 John 1:9). This passage, by the way, is in the immediate context of 1 John 1:7.

Yet some would have us believe in spite of this that somehow, someday, sometime, God will forgive his child of a slight infraction of sacred precepts, that walking in the light magically forgives casual sins—whatever that is!

That won’t wash! The verse under study says, “If we walk in the light, as he is in the light, we have fellowship one with another, and the blood of Jesus his Son cleanseth us from all sin.” We are continuously cleansed not from some sin, nor from haphazard sin, nor from unknown sin, but from all sin—all sin!

If walking in the light is something other than keeping all the commands of God, if it is approximate obedience and just getting close, then all sin—all sin!—adultery, murder, stealing, lying, idolatry—all sin—is automatically forgiven. The verse says “all sin,” just as verse 9 says “all unrighteousness.”

If the liberalizing view that grace dispenses with complete obedience to every requirement of heaven is true, then “all sin” is washed away in the blood of the cross unconditionally and all will be saved—Adolph Hitler and Charles Manson included. Simply put—Calvary was a mistake.

Some say “the light” is God, because verse 5 says, “God is light.” So, the passage would read, under this understanding, “if we walk in God, as Jesus walked in God. . . .” The question comes: How did Jesus walk in God—in the light?

*Question:* Did Jesus obey his heavenly Father incompletely and only when it was handy, or did he obey Jehovah always and in all things? The passage requires us to walk in the light as Jesus is in the light, if his blood is to keep on cleansing us from all sin. Jesus claimed sinless perfection and challenged his contemporaries to convict him of wrong (John 8:46-47). None did! He always pleased Jehovah (John 8:29). Keeping divine law gladdens the heart of God (1 John 3:22). Therefore Jesus always kept the commands of Jehovah, and that pleased his holy, heavenly Father. “Then said I, Lo, I am come (In the roll of the book it is written of me) To do thy will, O God” (Heb. 10:7). The unbending rule of the life of Jesus is “not my will, but thine be done.”

Jesus walked in the light, and so must we if his precious blood is to keep us clean from all sin. He never failed. We may fail, but provision is made for forgiveness, if we walk in the light as he is in the light.

It is tragic for a professing teacher of righteousness to

encourage people to think that any rule of God can be disregarded with impunity. Instead of trying to comfort the guilty by offering false hope, let us console them by rebuking sin and calling for repentance. "If we confess our sins, he is faithful and righteous to forgive us our sins, and to cleanse us from all unrighteousness."

"For we have not a high priest that cannot be touched with the feeling of our infirmities; but one that hath been in all points tempted like as we are, yet without sin. Let us therefore draw near with boldness unto the throne of grace, that we may receive mercy, and may find grace to help us in time of need" (Heb. 4:15-16).

Now, that gives some real help and lasting relief! "If we walk in the light, as he is in the light, we have fellowship one with another, and the blood of Jesus his Son cleanseth us from all sin."

## **Be Filled with the Spirit**

"And be not drunk with wine, wherein is excess; but be filled with the Spirit" (Eph. 5:18). Paul gives two commands in this verse. (1) Be not drunk with wine and (2) be filled with the Spirit. The first command demands a life of sobriety. The second command is generally misunderstood.

There are two possible explanations of the meaning of, "be filled with the Spirit." (1) It is a command to be filled with the actual Person of the Holy Spirit, or (2) It is a command to be filled with the Spirit's teaching. Let us consider these

views:

If the Spirit actually lives personally in the believer beginning at baptism (Acts 2:38), why would Paul command Christians to be “filled” with the Spirit? If the Spirit personally dwells in the saved person from the time of baptism, what role would the Christian have, then, in being filled with the Spirit?

If the Holy Spirit personally lives in the child of God personally at baptism, are there degrees or measures of the personal Holy Spirit abiding personally in the Christian? Is each individual Christian commanded to increase this initial measure of the Spirit until he becomes “filled” with the Spirit?

Brother Guy N. Woods’ chart graphically shows the parallel between Eph. 5:18-19 and Col. 3:16:

### ***Ephesians 5:18***

“Be filled with the Spirit.. ..speaking in psalms, hymns and spiritual songs...”

**“Be filled” present imperative. Keep on being filled! Daily filling—not a one-time experience following baptism.**

### ***Colossians 3:16***

“Let the word of Christ dwell in you richly. ...teaching in psalms, hymns and spiritual songs...”

### **How filled!**

Fill (*Pleero*)—Bagster: to pervade with an influence fully, possesses fully (Eph. 5:18).

Please note Bagster’s definition of the Greek *Pleero* (Fill) is to be filled with an influence. For one to “let the word of Christ dwell in” him “richly” is for him to “be filled with

the Spirit.”

It is true that the Spirit is not a mere influence. Still, the Bible frequently uses a figure of speech (synecdoche) where a part is put for the whole, or where the whole is put for a part. Here, the word *Spirit* is used for the Spirit’s influence through the teaching of the word of Christ.

This rich dwelling of the Spirit through the word results in “speaking in psalms, hymns and spiritual songs” or “teaching and admonishing one another.” One does not speak in psalms, hymns and spiritual songs as the result of being filled with the literal Person of the Holy Spirit. If so, then such singing would be the work of the Spirit, and all such teaching would be inspired. The Spirit influences people today only through the once-for-all delivered faith—the Word of Truth.

Which agrees with sound reason and with Scripture, to say (1) that being filled with the personal Spirit results from a command to do so, or (2) that being filled with the Spirit results from being obedient to commands of the Spirit and thus being filled with the Spirit’s teaching?

A study of Colossians 3:16 and Ephesians 5:18-19 shows that the singing of psalms, hymns and spiritual songs is the result of being “filled with the teaching of the Spirit,” or letting “the word of Christ dwell in you richly; in all wisdom teaching and admonishing one another with psalms and hymns and spiritual songs, singing with grace in your hearts unto God.”

# SENSITIVITY

## EIGHT STEPS TO GREATER SENSITIVITY

Jesus was the most sensitive person who ever walked the face of this earth. There have been many great heroes, great debaters, great scholars, and great orators, but how many people do you know who are great in their sensitivity? Many a church split, fuss, or wrangle would be solved were everyone more sensitive to each other. Jesus exhibited his sensitivity in at least eight ways.

## **He considered the physical needs of others:**

*And Jesus called unto him his disciples, and said, I have compassion on the multitude, because they continue with me now three days and have nothing to eat: and I would not send them away fasting, lest haply they faint on the way. And the disciples say unto him, Whence should we have so many loaves in a desert place as to fill so great a multitude? And Jesus said unto them, How many loaves have ye? And they said, Seven, and a few small fishes. And he commanded the multitude to sit down on the ground; and he took the seven loaves and the fishes; and he gave thanks and brake, and gave to the disciples, and the disciples to the multitudes. And they all ate, and were filled: and they took up that which remained over of the broken pieces, seven baskets full. And they that did eat were four thousand men, besides women and children. And he sent away the multitudes, and entered into the boat, and came into the borders of Magadan (Matt. 15:32-39).*

# Jesus taught that we should be willing to forgive others of their shortcoming seventy times seven:

*Then came Peter and said to him, Lord, how oft shall my brother sin against me, and I forgive him? until seven times? Jesus saith unto him, I say not unto thee, Until seven times; but, Until seventy times seven. Therefore is the kingdom of heaven likened unto a certain king, who would make a reckoning with his servants. And when he had begun to reckon, one was brought unto him, that owed him ten thousand talents. But forasmuch as he had not wherewith to pay, his lord commanded him to be sold, and his wife, and children, and all that he had, and payment to be made. The servant therefore fell down and worshipped him, saying, Lord, have patience with me, and I will pay thee all. And the lord of that servant, being moved with compassion, released him, and forgave him the debt. But that servant went out, and found one of his fellow-servants, who owed him a hundred shillings: and he laid hold on him, and took him by the throat, saying, Pay what thou owest. So his fellow-servant fell down and besought him, saying, Have patience with me, and I will pay thee. And he would not: but went and cast him into prison, till he should pay that which was due. So when his fellow-servants saw what was done, they were exceeding sorry, and came and told unto their lord all that was done. Then his lord called him unto him, and saith to him, Thou wicked servant, I forgave thee all that debt, because thou besoughtest me: shouldest not thou also have had mercy on thy fellow-servant, even as I had mercy on thee? And his lord was wroth, and delivered him to the tormentors, till he should pay all that was due. So shall also my heavenly Father do*

*unto you, if ye forgive not every one his brother from your hearts (Matt. 18:21-35).*

## **Jesus considered the spiritual needs of others—even when they were not interested:**

*O Jerusalem, Jerusalem, that killeth the prophets, and stoneth them that are sent unto her! how often would I have gathered thy children together, even as a hen gathereth her chickens under her wings, and ye would not! Behold, your house is left unto you desolate. For I say unto you, Ye shall not see me henceforth, till ye shall say, Blessed is he that cometh in the name of the Lord (Matt. 23:37-39).*

## **Jesus taught that we should do what we could to solve the obvious problems of others:**

*And behold, a certain lawyer stood up and made trial of him, saying, Teacher, what shall I do to inherit eternal life? And he said unto him, What is written in the law? how readest thou? And he answering said, Thou shalt love the Lord thy God with all thy heart, and with all thy soul, and with all thy strength, and with all thy mind; and thy neighbor as thyself. And he said unto him, Thou hast answered right: this do, and thou shalt live. But he, desiring to justify himself, said unto Jesus, And who is my neighbor? Jesus made answer and*

*said, A certain man was going down from Jerusalem to Jericho; and he fell among robbers, who both stripped him and beat him, and departed, leaving him half dead. And by chance a certain priest was going down that way: and when he saw him, he passed by on the other side. And in like manner a Levite also, when he came to the place, and saw him, passed by on the other side. But a certain Samaritan, as he journeyed, came where he was: and when he saw him, he was moved with compassion, and came to him, and bound up his wounds, pouring on them oil and wine; and he set him on his own beast, and brought him to an inn, and took care of him. And on the morrow he took out two shillings, and gave them to the host, and said, Take care of him; and whatsoever thou spendest more, I, when I come back again, will repay thee. Which of these three, thinkest thou, proved neighbor unto him that fell among the robbers? And he said, He that showed mercy on him. And Jesus said unto him, Go, and do thou likewise (Luke 10:25-37).*

## **Jesus taught that sensitivity is often met by insensitivity:**

*And it came to pass, as they were on the way to Jerusalem, that he was passing along the borders of Samaria and Galilee. And as he entered into a certain village, there met him ten men that were lepers, who stood afar off: and they lifted up their voices, saying, Jesus, Master, Have mercy on us. And when he saw them, he said unto them, Go and show yourselves unto the priests. And it came to pass, as they went, they were cleansed. And one of them, when he saw that he was healed, turned back, with a loud voice glorifying God; and he fell upon his face at his feet, giving him thanks: and he was*

*a Samaritan. And Jesus answering said, Were not the ten cleansed? but where are the nine? Were there none found that returned to give glory to God, save this stranger? And he said unto him, Arise, and go thy way: thy faith hath made thee whole (Luke 17:11-19).*

## **Jesus taught that we should accept those who were unacceptable to much of society:**

*And they come to Jericho: and as he went out from Jericho, with his disciples and a great multitude, the son of Timaeus, Bartimaeus, a blind beggar, was sitting by the way side. And when he heard that it was Jesus the Nazarene, he began to cry out, and say, Jesus, thou son of David, have mercy on me. And many rebuked him, that he should hold his peace: but he cried out the more a great deal, Thou son of David, have mercy on me. And Jesus stood still, and said, Call ye him. And they call the blind man, saying unto him, Be of good cheer: rise, he calleth thee. And he, casting away his garment, sprang up, and came to Jesus. And Jesus answered him, and said, What wilt thou that I should do unto thee? And the blind man said unto him, Rabboni, that I may receive my sight. And Jesus said unto him, Go thy way; thy faith hath made thee whole. And straightway he received his sight, and followed him in the way (Mark 10:46-52).*

# Jesus was blind to social restraints, and treated all people as real people:

*So he cometh to a city of Samaria, called Sychar, near to the parcel of ground that Jacob gave to his son Joseph: and Jacob's well was there. Jesus therefore, being wearied with his journey, sat thus by the well. It was about the sixth hour. There cometh a woman of Samaria to draw water: Jesus saith unto her, Give me to drink. For his disciples were gone away into the city to buy food. The Samaritan woman therefore saith unto him, How is it that thou, being a Jew, askest drink of me, who am a Samaritan woman? (For Jews have no dealings with Samaritans.) Jesus answered and said unto her, If thou knewest the gift of God, and who it is that saith to thee, Give me to drink; thou wouldest have asked of him, and he would have given thee living water. The woman saith unto him, Sir, thou hast nothing to draw with, and the well is deep: whence then hast thou that living water? Art thou greater than our father Jacob, who gave us the well, and drank thereof himself, and his sons, and his cattle? Jesus answered and said unto her, Every one that drinketh of this water shall thirst again: but whosoever drinketh of the water that I shall give him shall never thirst; but the water that I shall give him shall become in him a well of water springing up unto eternal life. The woman saith unto him, Sir, give me this water, that I thirst not, neither come all the way hither to draw. Jesus saith unto her, Go, call thy husband, and come hither. The woman answered and said unto him, I have no husband. Jesus saith unto her, Thou saidst well, I have no husband: for thou hast had five husbands; and he whom thou now hast is not thy husband: this hast thou said truly. The woman saith unto him, Sir, I perceive that thou art a prophet. Our fathers worshipped in this mountain; and*

*ye say, that in Jerusalem is the place where men ought to worship. Jesus saith unto her, Woman, believe me, the hour cometh, when neither in this mountain, nor in Jerusalem, shall ye worship the Father. Ye worship that which ye know not: we worship that which we know; for salvation is from the Jews. But the hour cometh, and now is, when the true worshippers shall worship the Father in spirit and truth: for such doth the Father seek to be his worshippers. God is a Spirit: and they that worship him must worship in spirit and truth. The woman saith unto him, I know that Messiah cometh (he that is called Christ): when he is come, he will declare unto us all things. Jesus saith unto her, I that speak unto thee am he (John 4:1-26).*

**Jesus said to always put God and others first; that way, we'll never get in our way.**

*But the Pharisees, when they heard that he had put the Sadducees to silence, gathered themselves together. And one of them, a lawyer, asked him a question, trying him: Teacher, which is the great commandment in the law? And he said unto him, Thou shalt love the Lord thy God with all thy heart, and with all thy soul, and with all thy mind. This is the great and first commandment. And a second like unto it is this, Thou shalt love thy neighbor as thyself. On these two commandments the whole law hangeth, and the prophets (Matt. 22:34-40).*

These eight steps are simple, yet profound. Brethren, be more sensitive to the needs of those around us, try to be like Jesus!

# BABIES ARE NOT BORN IN SIN!

The idea of babies being born in sin is foreign to the Bible. Babies do not inherit sin from their parents.

“The soul that sinneth, It shall die. The son shall not bear the iniquity of the father, neither shall the father bear the iniquity of the son: the righteousness of the righteous shall be upon him, and the wickedness of the wicked shall be upon him” (Ezek. 18:20).

Children are born in a perfect state. “Thou wast perfect in thy ways from the day that thou wast created, till iniquity was found in thee” (Ezek. 28:15). Jesus said that unless we humble ourselves and become as little children, we cannot enter the kingdom of heaven (Matt. 18:1-4).

Among the denominations that teach this false doctrine the misuse of Psalm 51:5 is predominant. That verse says, “Behold, I was shapen in iniquity: and in sin did my mother conceive me.” Some modern versions mistranslate the phrase “I was born a sinner.”

There is a vast difference in the meaning of the translations. In the King James and American Standard the mother did the sinning, but, in the New International for instance, it was the baby that was the sinner! The older versions are correct.

We know this in two ways. First, the original language states it emphatically, as do the King James and American Standard. Second, since the Bible does not contradict itself, and verses such as Ezekiel 18:20; 28:15; and Matthew 18:1-4 teach that

babies are not born sinners, the statement that a baby was born in sin cannot be true.

One might ask, if that is not the meaning of Psalm 51:5, then what can it mean? First, it is a Repentance Psalm. David committed adultery and murder (2 Sam. 11:1-27). He said, "my sin is ever before me" (Ps. 51:3). Because of his terrible guilt, he felt he had been sinning so long he couldn't remember when he started.

There is another scriptural explanation for this. Deuteronomy 23:3 says, "An Ammonite or Moabite shall not enter into the congregation of the Lord; even to his tenth generation shall he not enter into the congregation of the Lord." In Ruth 1:4 we find two Israelite men marrying Moabite women, one of which was Ruth. Ruth was the great-grandmother of the author of Psalm 51—David!. He was within "ten generations" of a Moabite! That may be why he said, "in sin did my mother conceive me."

There has never been a baby that believed (Mark 16:16). There has never been a baby that repented (Acts 2:38). There has never been a baby who had his sins washed away (Acts 22:16), because there has never been a baby that sinned!

## **NOTES ON AUTHORITY**

A necessary question is, What is Scriptural authority? Sometimes people who ask this mean, where is this or that specifically mentioned in the Bible as approved of God?

The truth is some things are authorized by the New Testament

that are not specifically named. This brings up the subject of the two kinds of authorization found in the New Testament.

First: specific authorization is a given practice named with God's approval. Many examples can be cited, such as going into all the world with the gospel (Mark 16:16), assembling each first day of the week to partake of the Lord's supper (Acts 20:7), and baptizing people in the name of Christ for the remission of sins (Acts 2:38).

Second: authorization permitting the use of arrangements not specifically mentioned in the Bible. For example automobiles are not mentioned in Mark 16:16, but are authorized in obeying the command to go into all the world with the Gospel? A plate is not mentioned for serving the bread of the Lord's supper, but is it allowable?

For a thing to be generally authorized there must be behind it the implementing of some specific command. A thing resting upon generic authority must not conflict with any other precept of Scripture. Using a car to preach the Gospel is scriptural, but one may not steal a car in order to preach the gospel.

Building a church building rests upon generic authority and not specific authority. The command to assemble (Heb. 10:25) implies a place to assemble, whether borrowed, rented, or purchased.

Many things about a church building fall in the realm of generic authority. Restrooms, water fountains, carpet on the floor, padding on the pews, ceiling fans and other things fall into this category.

The use to which property of a local church can be put is in this realm. Who is to decide such matters? The obvious answer is the elders. Elders have oversight of every optional part of the work and activity of the local congregation (Heb. 13:17).

Elder's authority does not extend to releasing what Christ has bound or binding what He has released (Matt. 16:19-20). The Lord has made all the spiritual law men need (2 Tim. 2:15), and He has left it with us in His "perfect law of liberty" to implement his teaching.

Elders, like every child of God, must protect against false teachers, and keep the church faithful to the law of Christ (Acts 20:28-30). Elders have oversight of the policy and programs of the local church. They determine what will be done in matters of generic authority.

Electricity and plumbing in the building; eating a meal on the church premises; whether one or more gospel meetings per year; whether to have a lectureship every year and what subjects to study, and the speakers; whether to publish a book and audio and video tapes with which to preserve the messages for further reflection and wider distribution all fall into this category—all are matters of general authority, but authority nonetheless.

The specific authority for a lectureship, publication of a book, and tape recordings of the messages are found in the command to preach the Gospel to the whole creation (Mark 16:16). If such lectureships have solid authority, and if the reproduction of the messages by print and tape rests upon solid authority, then it must follow that distribution of said materials also rests upon solid authority.

If it is right to produce such materials for the Gospel on church property, is it right to sell such, for a fair price, on the same property?

The same general authority authorizing a church building, water, electricity, and gas, authorize the making and distribution of sound Gospel materials for the information of saints. Is the church supporting private business when the plumbing fails, and the plumber makes repairs for which the

church pays? A plumber is not expected to clean out the sewer lines for nothing!

Some think a thing is all right as long as it is small, but when it is big it is wrong. Question: how big is big, and by whose judgment? Such a person is a law maker for God!

Another point relating to littleness/bigness. Neither size nor quantity has anything to do with the rightness or wrongness of a matter of judgment. If it is not wrong for an eldership to decide to install a refrigerated drinking fountain in the church building, then it is not wrong to install a refrigerator in a church building. The size of the thing has nothing to do with it! If it is wrong for people to eat bread and fish in the church building, then it is wrong for the church to install a drinking fountain. Conversely, if it is right to install a drinking fountain, it is right to eat bread and fish (or even chicken) in the church building.

## **SALVATION IS BY GRACE BUT NOT BY GRACE ONLY**

There is an enormous difference between affirming (1) that salvation is by grace and (2) that salvation is by grace only. The difference is of great importance.

Recently, I saw an article written by a brother in Christ which alleges that it "is a scandalous and outrageous lie to teach that salvation arises from human activity. We do not contribute one whit to our salvation." (Rubel Shelly, "Love

*Lines,*" October 31, 1990; Woodmont Hills Bulletin, Nashville. p. 3.)

It is quite serious to charge brethren with lying.

These statements remind me of the booklet (Sam Morris, *Do A Christian's Sins Damn His Soul?* [Sic] [No publisher or date indicated], pp. 1-2, written by a Baptist preacher) which affirms that all of the deeds which one may do in obedience to the Gospel of Christ "will not make his soul one whit safer." In so saying, he taught that loving obedience to Jesus Christ has nothing whatever to do with his becoming a Christian or, finally, with his going to Heaven when Jesus comes again to judge the world.

In regard to the sins which one may commit, the same booklet teaches that "all the sins he may commit from idolatry to murder will not make his soul in any more danger. The justification of the human soul is through the atonement of Christ and not through the efforts of man. **The way a man lives has nothing whatever to do with the salvation of his soul**" (emphasis mine. TBW).

Let us compare these two statements.

The Baptist said: "The way a man lives has nothing whatever to do with the salvation of his soul."

Our brother said: "We do not contribute one whit to our salvation" and that it is an "outrageous lie to teach that salvation arises from human activity."

How do the statements compare? Is there a significant difference between them? I aver that there is not.

They both teach salvation by grace only.

Our brother taught that it is an outrageous lie to teach that salvation "arises from human activity."

The Baptist also taught that the way a man lives (this would include all of his thoughts and deeds) has nothing whatever to do with his salvation. So, this is a clear affirmation that after the moment when one believes in Christ, there is nothing he can do which would result in his eternal damnation. I even heard one Baptist preacher say, "Since I trusted Jesus as my personal Savior, I could not go to Hell even if I wanted to!" Also, during debates, I have heard Baptist preachers argue that John 6:28-29 teaches, not that man must do the believing, but that God does the believing for him.

Our brother eliminates all human activity from salvation. If he were right, then every human being will be saved, because God's grace is offered to all men (Titus 2:11)! So, if this false doctrine really were true, then there would be no need for the preaching of the Gospel (all men would be saved without it, without ever hearing it, without ever believing it, without ever obeying it) either to become a Christian or in the living of the Christian life. May it be remembered, that the brother whom we are reviewing also taught that "good works are the fruit of salvation." Given this doctrine, the things we do in becoming a Christian are not "good works." This he teaches in spite of such passages as James 2:24-26.

In contradiction to our brother's positions, the New Testament conditions both becoming a Christian and living a life which will result in eternal salvation on certain specified things. The Holy Spirit, in inspiring the writing of the New Testament, put the little word "if" before quite a number of conditions. Following are just a few of such passages: (1) Galatians 6:7-9: "... in due season we shall reap IF we faint not" (Gal. 6:7-9); (2) Hebrews 10:26: "For IF we sin wilfully after that we have received the knowledge of the truth, there remaineth no more a sacrifice for sins" [emphases mine in the two preceding points]; (3) Galatians 1:6-9 clearly teaches that if any one preaches a gospel which is different from that of Christ, he will be under the curse of God.

There are many other passages which use "if" in this fashion. May all people be warned that there are works (acts of obedience which are required by Christ in the Gospel) which one must do in order to become a Christian. Also, there are works which one must do in order to go to Heaven when this life is over.

I want to lovingly affirm without reservation that no one can be saved without the grace of God—no one can earn his salvation. Every person who is saved is saved by grace! But—note this please—no one is saved by grace only! People are saved by the grace of God when by faith they obey the relevant instructions of Christ, who taught that only those who do the will of the Father will enter the kingdom of heaven (Matt. 7:21). Our brother contradicts Jesus, His Apostles, and His prophets.

It should be clear that while the works of man cannot earn the forgiving of even one sin, it is nevertheless the case that salvation by the grace of God is contingent on man's faith in, and obedience to, the Lord Jesus Christ (Heb. 5:8-9).

James 2:24-26 and Revelation 2:10, among many other passages, ought to settle it for all of us: (1) those who live and die in faithfulness to the Gospel of Christ will be saved eternally and (2) those who live and die in unfaithfulness to the Gospel of Christ will be lost eternally (cf., James 2:24-26; Matt. 25:46).

One is saved by grace but faith also has a part (Eph. 2:8-9). But Christ says, through His word, that men are saved by works and not by faith only (James 2:24-26).

The seed of God (His word) must be both believed and obeyed (Luke 8:4-15). Each person is free either to stay in the "mudhole" of sin or, by faith and obedience, to get out of the "mudhole" of sin (2 Peter 2:20-22).

Again, I kindly suggest, that ought to settle the matter for

all of us.

# Come to Dinner

## **Matthew                    22:2-14,                    Luke** **14:16-24**

This parable could be called "The Parable of the Great Invitation" or "The parable of Frivolous Excuses." It is a call to dinner. "All things are ready, come."

"The kingdom of Heaven is like unto" (Matt. 22:2). Then He describes certain things about the kingdom of God. This is a judgment parable and contains these central thoughts: (1) The guilt of the Jewish nation for rejecting God's word; (2) God will have a people nevertheless; (3) Since the Jews rejected the gospel message, his servants invited others.

Standing out clearly in the scripture is the importance of the call. In both the Old and the New Testaments, feasts denote spiritual blessings. The feast in this parable is the gospel of the kingdom of heaven. Since this is a call of God to accept the gospel message, it is all important. The certain king of the parable points to the great God of the universe, the King of kings and Lord of lords. Since it is the King's dinner, the invitation is tremendously important.

In the second place, this call is important because the feast honors the King's son. Christ refers to Himself. He is the son

of God. If the king was giving a dinner in honor of a servant perhaps the call to attend would not be so important, but he is honoring his son. This makes the invitation all important. To refuse the invitation dishonors the son.

The Bible teaches every knee should bow and every tongue should confess that Jesus Christ is Lord to the glory of God, the Father (Phil. 2:10-11). Since this confession and homage is inevitable, we must either make the confession here or hereafter. We should gladly accept this great invitation.

Third, this call to dinner is important because of the immense preparation, "all things are ready" (Luke 14:17). Nothing is undone. Can we not see the great banquet table groaning under the load of luxurious delicacies? Nothing is omitted. No expense is spared. Calvary is an accomplished fact. The blood of the Lamb of God soaked into the wood of the cross, and dripped to the ground beneath the accursed tree.

"All things are ready." Think of what the great spiritual feast cost the Father. It cost His only begotten son. The preparation was most elaborate but very necessary. There was no other way for man to come to God to be forgiven. It took the sacrifice of Jesus Christ, the very son of God. What an important call and how tragic it is to reject it.

Fourth, the punishment of those who refused the call shows the importance of the call to dinner. If it seems drastic for the disappointed king to send his armies to destroy those who rejected his invitation, and killed his servants, consider the importance of the invitation. If you think the man found at the supper table without a wedding garment was too severely punished for his neglect, weigh the significance of this invitation he had slighted.

Those who heard the call and rejected the invitation suffered severe punishment. Christ's prophecy, for the Jewish nation, came to pass in the year A.D. 70, when the Roman armies, under

Titus, laid siege to the city of Jerusalem and razed it to the ground. The terrible destruction of Jerusalem in the first century of this age is a kind of prophecy of the utter destruction that awaits the impenitent at the close of this age. Modern day people should take note, and shudder.

This call is universal—to the Jew first, and also to the Greek (Rom. 1:16). In the parable under discussion the elite received the invitation. They turned it down with scorn and frivolous excuses. The King's servants then went out into the highways and hedges looking for guests. The Jews rejected Christ and cried, "His blood be on us and on our children" (Matt. 27:25). At first, the offer of salvation was to the Jews. When they rejected it, the teachers turned to the Gentiles.

The call was to dine at the great banquet table of the Lord. It is universal, God is not a respecter of persons. "Whosoever will" is the language of the scriptures. His loyal servants are still delivering the message all over the world that whosoever will may come to Christ and obey His gospel. It is a message of love, and freedom. Thank God, everyone has an invitation to attend this great wedding feast.

This call is for preparation. Orientals wore long white robes at public festivals. Those who appeared with any other garments were culpable, and punished. The wedding garment is the righteous deeds of the saints. If we obey the commands of Jesus to believe and be baptized the promise of salvation from past sin is ours (Mark 16:16). If we are faithful at all costs, we will receive a crown of life (Rev. 2: 10). Obedience to the plan of salvation, and clean living, and faithful service are the right clothes for this feast. No one attended this banquet with improper robes. Common clothes would insult the king, and dishonor his son. If we are to enjoy the great blessings of God we must make preparation. Why should anyone appear in filthy rags when clean garments are available? "He that is unrighteous, let him do unrighteousness still: and he

that is filthy, let him be made filthy still: and he that is righteous, let him do righteousness still: and he that is holy, let him be made holy still” (Rev. 22:11).

This call also contains a warning. Much of our Lord’s teaching is interspersed with warnings. Those first bidden began to make excuses—feeble, flimsy, foolish, frivolous excuses. Verse 7 tells the consequences of the refusal of the call to dinner: “But when the king heard thereof, he was wroth; and he sent forth his armies, and destroyed those murders, and burned up their city.” Verse 13 tells what happened to the poor fellow who tried to get by with unfit garb: “Bind him hand and foot, and take him away, and cast him into outer darkness; there shall be weeping and gnashing of teeth.”

These things are for our admonition. Transgression deserves severe punishment. Notice that these people “made light of it and went their ways.” Some took his servants and treated them shamefully, slaying them. One man came, “not having on a wedding garment.” These words speak disaster. The call of God contains a warning. It is tragical to go about your business as if nothing happened. You can enjoy a feast of good things at the Father’s table. It’s up to you!

## **Spirituality – What is it?**

The word spirituality is often used to describe worked-up-emotion, which is a horrid caricature of the sober and sacred idea. The New Testament uses the adjective *pneumatikos* (translated spiritual) twenty-six times. What is spirituality?

# Paul's Spiritual Man

Paul contrasts the natural man and the spiritual man, and describes the natural man as one who "receives not the things of the Spirit of God: for they are foolishness unto him: neither can he know them, because they are spiritually discerned. But he that is spiritual judgeth all things" (1 Cor. 2:14-15). Martin Luther pictured man in his natural state "like a pillar of salt, like Lot's wife, yea, like a log and a stone, like a lifeless statue which uses neither eyes nor mouth, neither sense nor heart, incapable of understanding the things of God until he is enlightened, converted, and regenerated by the Holy Ghost."

According to Luther, the natural man cannot understand the Bible. He needs special illumination from the Spirit to discover the message of the Scriptures. The spiritual man, according to this view, is, at first, like a lifeless statue incapable of understanding the scriptures, but after being regenerated by a direct operation of the Holy Spirit, he is illuminated and converted. The teaching of Luther does not agree with the teaching of the New Testament, but is popular with many well-meaning, deceived people.

Paul contrasts the gospel he preached with false doctrines of false teachers. In first Corinthians chapter one, the apostle helps us to understand the term spiritual. The words "foolish" and "foolishness" are used seven times and "wise" and "wisdom" twelve times to contrast God's wisdom with man's wisdom (foolishness). "Hath not God made foolish the wisdom of this world" (1 Cor. 1:20). Paul is discussing God given teaching versus human philosophy.

Paul affirms that his preaching was "not with enticing words of man's wisdom" (1 Cor. 2:4). In the first two chapters of 1 Corinthians, Paul develops the theme that Christianity is a revealed religion, and that man, without revelation, cannot

know the blessings of redemption. God reveals redemption, and also its interpretation and explanation (see 1 Pet. 1:10-12). Paul proclaims, "God hath revealed them unto us by his Spirit; for the Spirit searcheth all things, yea, the deep things of God" (1 Cor. 2:10). The plural pronouns of verses 10-13 do not refer to Christians of all ages (the very thing that Luther misunderstood), but to the apostles and other inspired teachers of the first century who were involved in revealing "the faith which was once for all delivered unto the saints" (Jude 3).

Paul's "natural" man is the uninspired man, and his "spiritual" man is the inspired man. Paul uses the word "spiritual" in 1 Cor. 14:37 with the same meaning: the spiritual man was guided by the Holy Spirit, and miraculously empowered.

Paul contrasts inspired revelation with false teaching. To make the passage mean a sinner who cannot understand the Bible until the Holy Spirit interprets it for him is a terrible perversion. If the sinner cannot understand the gospel until he receives supernatural illumination, and if illumination never comes, God is at fault.

## **The Spiritual Man Today**

In 1 Corinthians 3:1, Paul uses the word spiritual with a different emphasis. Paul accuses the brethren in Corinth of being carnal, and therefore of not being spiritual. The carnal man, oblivious to the gospel, is sinful. The spiritual person, influenced by the gospel, is godly. This is the way the term spiritual ought to be understood by mankind in today's religious world. Inspiration has ceased, and there is no progressive revelation of saving truth today. Paul's usage of spiritual in 1 Corinthians 2 applied only to the first century in the age of miraculous manifestations of the Spirit.

The word spiritual may mean, in the New Testament, things that have their origin with God, and are in harmony with his character. Passages such as Romans 7:14; 1 Corinthians 9:11 and 10:3; and Ephesians 1:3 are examples of this usage.

The Apostle Paul writes the brethren in Galatia that “if a man be overtaken in a fault, ye which are spiritual restore such an one in the spirit of meekness; considering thyself, lest thou also be tempted” (Gal. 6:1). There are two classes in this verse. One is spiritual, and the other is not. Spirituality was something that was recognizable, else no one would know who was to restore who!

The spiritual person today is the one who walks by the Spirit, and does “not fulfil the lust of the flesh” (Gal. 5:16). The fruit of the Spirit will be seen in the life (Gal. 5:22-25). Vine’s Expository Dictionary points out that in 1 Corinthians 3:1-3, “Paul contrasts the spiritual state of a mature Christian with that of the babe in Christ, i.e., of the man who because of immaturity and inexperience has not yet reached spirituality, and that of the man who by permitting jealousy, and the strife to which jealousy always leads, has lost it. The spiritual state is reached by diligence in the Word of God and in prayer; it is maintained by obedience and self-judgment.”

“But grow in the grace and knowledge of our Lord and Saviour Jesus Christ. To him be the glory both now and for ever. Amen” (2 Pet. 3:18).

## **SOME ARGUMENTS AGAINST SOCIAL**

# DRINKING

Some say the Bible condemns drunkenness, but not social drinking. A cocktail before dinner or wine with one's meal is acceptable Christian conduct, according to some.

As some point out, Jesus turned water into wine at a wedding feast (John 2:1-11) and Paul told Timothy, "Drink no longer water but use a little wine for thy stomach's sake and thine often infirmities" (I Timothy 5:23). The qualifications for elders and deacons say one must not be "given to wine" or "given to much wine" (I Timothy 3:3,8). Some say elders and deacons may drink wine in moderate amounts.

Let us briefly examine these arguments. First, Jesus made approximately 120 gallons of wine for a wedding in Cana of Galilee (John 2:1-11). The word "wine" (John 2:3, 10) is *oinos*, a generic term which could mean either fermented or not fermented juice. If this means intoxicating drink, several problems arise: (1) Jesus did what was strictly forbidden in the Law: "Look not thou upon the wine when it is red, when it sparkleth in the cup.. ." (Proverbs 23:31); (2) Jesus would have been tempting them to drunkenness in violation of Habakkuk 2:15: "Woe unto him that giveth his neighbor drink, to thee that addest thy venom, and makest him drunken also..." (3) Jesus would have provided a drink in such quantity to make hundreds drunk in defiance of many passages that condemn drunkenness. The sinless Jesus made non-intoxicating "wine" at the wedding feast. Therefore, his example cannot be cited as an argument for social drinking!

Regarding 1 Timothy 3:3,8 and Titus 1:7, "not given to wine" and "not given to much wine," let us notice two things. (1) To be consistent, those who say that "much wine" implies one may

drink “a little wine” would have to affirm that Ecclesiastes 7:17, “Be not overmuch wicked” means it is right to be moderately wicked! Also, “Let not sin therefore reign in your mortal body” (Romans 6:12) means there is nothing wrong with sin, if it does not take control of one’s life! (2) “Not given to wine” is *paroinos* (I Timothy 3:3; Titus 1:7). This is a compound Greek *word–para* (at, by the side of, near) and *oinos* (wine). Thus, *paroinos* would literally mean that an elder must not be at, by the side of, or near wine. The word wine in these passages would obviously mean intoxicating wine. We conclude these passages cannot be used to argue for social drinking. What of Paul’s instruction to Timothy to “drink no longer water, but use a little wine for thy stomach’s sake and thine often infirmities” (I Timothy 5:23)? Consider: (1) Timothy must have been a total abstainer, else this apostolic admonition would not have been necessary; (2) he was told to use a little wine, not a large amount; (3) the instruction was in view of a physical ailment. Therefore, Timothy was not told to drink wine socially. There is absolutely nothing in the passage to support social drinking!

Advocates of social drinking must look elsewhere to justify their practice. Brethren who love the Lord and the church will strive to lead pure and holy lives in the sight of God and their fellow man.

# A Habitation of God Through the Spirit

Ephesians 2:22 is sometimes cited to support the view that the

Holy Spirit personally indwells the Christian in a direct and in-Person manner. Often the question will be asked: "How can God dwell in us through the Spirit if the Spirit does not indwell us?" The phrase, "through the Spirit," in this Ephesians verse, is thought by some to mean that God, being in the Spirit, indwells us indirectly, figuratively, or representatively through (by means of) the Holy Spirit who is literally in us in his own Person.

Does this verse in the Ephesian letter, in fact, teach that the Spirit indwells one literally and immediately, as some affirm? This phrase, "through the Spirit," occurs at least four times in the New Testament (Acts 21:4; Rom. 8:13; Eph. 2:22; 1 Peter 1:22, KJV). An examination of the other three references will show that this phrase, through the Spirit does not refer to an indwelling of the Spirit. Notice the similar usages of these four references:

- 1) "...who said to Paul through the Spirit..." (Acts 21:4)
- 2) "...through the Spirit do mortify the deeds..." (Rom. 8:13)
- 3) "...a habitation of God through the Spirit" (Eph. 2:22)
- 4) "...obeying the truth through the Spirit..." (1 Peter 1:22)

Notice the similar meanings of this phrase, "through the Spirit" in these four references:

"And finding disciples, we tarried there seven days: who said to Paul through the Spirit, that he should not go up to Jerusalem" (Acts 21:4). The Holy Spirit made known to the disciples at Tyre that Paul would be in danger of his life if he returned to Jerusalem (see also Acts 21:10-14). Here "through the Spirit" means "by the Spirit" (ASV). That is, the Spirit had warned the brethren of the danger that awaited Paul at Jerusalem. This information given the disciples by the Spirit was inspired revelation.

“For if ye live after the flesh, ye shall die: but if ye through the Spirit do mortify the deeds of the body, ye shall live” (Rom. 8:13). Who would argue this means if those Roman Christians would mortify the deeds of the body “through the Spirit” that indwelt them, they would live? It is apparent Paul was telling them if they would mortify the deeds of the body through the Spirit’s teaching, that is, according to what the Spirit taught, they would live.

“In whom ye also are built together for an habitation of God through the Spirit” (Eph. 2:22). How are Christians built together for a habitation of God? Is our being built together accomplished by the Spirit as he literally indwells us? If so, then would our being built together not be a direct operation of the Holy Spirit? Again, in this Ephesians 2:22 reference, the phrase “through the Spirit” could have been rendered “by the Spirit.” Our obedience to the Spirit’s teaching builds together as “a spiritual house” (1 Peter 2:5). This verse does not allude to a direct, personal, immediate indwelling of the Spirit. It is a misapplication of Ephesians 2:22 to use it to teach that the Spirit indwells us literally in his own Person.

“Seeing ye have purified your souls in obeying the truth through the Spirit unto unfeigned love of the brethren, see that ye love on another fervently” (1 Peter 1:22). Who would affirm that one’s “obeying the truth” is effected “through the Spirit” that literally indwells him? We know that one obeys the truth through, or by, the Spirit’s influence exerted through, or by, the inspired Word of God. The Spirit’s only influence upon the human heart or conscience is through the message of the inspired Word of God, and never by direct operation. In like manner we are built together for a habitation of God, Christ and the Holy Spirit through the influence exerted by the Spirit in the inspired Word of life (John 6:63-68).

# What About the Rapture?

The rapture is a widely accepted denominational doctrine. Popular TV and radio evangelists teach this idea. Several best-selling religious books deal with this subject. Hal Lindsey's book, *The Late Great Planet Earth*, became a Hollywood movie. This book, first printed in 1970, was so popular that by 1976 it had gone through forty-two printings!

The result of this blitz of teaching is alarming. The news media mentioned the War in the Persian Gulf as maybe connected with Armageddon. Many people are using the term "the rapture" as if it was a commonly known and established future event, but the word "rapture" is not in any credible translation of the Bible.

The denominational idea of a coming rapture confuses folk and makes it difficult for them to understand and accept the truth. It is necessary to combat this false teaching before we can begin successfully to teach basic Bible truth. Some members of the church have accepted the teaching as Biblical. Brethren, we must teach the truth on "end times" and answer this false doctrine.

This incorrect view of "the rapture" says that Christ will soon appear and take the saved away from the earth for a seven-year rapture, leaving the unsaved on the earth to suffer. Most of us have read articles or heard hair-raising stories on what these people say will occur when Christ raptures the saved.

The anecdotes tell of men waking up and finding their wives

and children mysteriously gone. Others, at work, abruptly disappear from their machines and desks. Drivers and pilots suddenly vanish, causing crippling crashes.

Those not raptured panic, not knowing what has happened. The phone lines are jammed as people call the police, the newspaper office, the radio station. Disorder is rampant. Finally, some slowly realize the “rapture” has taken place, and they, not ready, were left behind. Meanwhile, the saved have inexpressible bliss.

## **TOO NEW TO BE BIBLICAL**

Few people seem to know this unbiblical teaching is somewhat new. Although the false doctrine of premillennialism has been around for a while, dispensational premillennialism (from which comes the rapture idea) is dated from about 1830, beginning with John N. Darby and the start of the Plymouth Brethren movement.

One writer claims the two-stage idea of Christ’s coming commenced with Miss Margaret MacDonald in Port Glasgow, Scotland a few years earlier. No one can trace it back before the 1800’s. This shows the doctrine to be unscriptural. It started 1700 years too late to be from God!

## **THE DISPENSATIONAL PREMILLENNIAL THEORY EXPLAINED**

Dispensationalists, generally, teach that all human history falls into seven divisions. They disagree on the designations and the exact periods covered in the first five dispensations, but all agree we are now living in the sixth period, called,

by them, the Dispensation of Grace. They expect the seventh dispensation to last one thousand years and call it, The Millennium.

Most say the Dispensation of Grace will soon end with the reputed rapture. The living righteous will be caught up to meet Christ in the air to be judged and rewarded. The rapture lasts seven years (the "final week" of Daniel's prophecy – Daniel 9:27)

On earth, during this seven-year period, is The Great Tribulation. During the first part of this period, the Jews in Palestine make a covenant with Antichrist. They rebuild the temple, renew its sacrifices, and convert many to Judaism.

In the middle of this seven-year period the Antichrist breaks covenant with the Jews and demands to be worshiped. Multitudes are slaughtered in a great persecution.

After seven years, Christ comes back to earth with the raptured saints. Dispensational premillennialists call this The Revelation. The battle of Armageddon is fought and the Antichrist is destroyed in the war.

The righteous dead are, at last, remembered and resurrected. All the nations are judged. The millennium begins. Christ rules the world from earthly Jerusalem, sitting on David's literal throne. After the thousand years, Satan is loosed for a little while. After Satan's last fling, the wicked dead are resurrected and judged in "The Great White Throne Judgment."

## **A PROOF TEXT**

Teachers of dispensational premillennialism claim First Thessalonians teaches their speculation about a rapture and tribulation and millennial reign of Jesus on earth. "Then we which are alive and remain shall be caught up together with them in the clouds, to meet the Lord in the air: and so shall

we ever be with the Lord" (1 Thess. 4:17).

The verse does mention the living saved, along with the resurrected saved, caught up to meet the Lord in the air, however the passage speaks of what occurs after all the dead are raised and judged and says nothing of a secret rapture. The passage also indicates the redeemed in Hades are resurrected and the saved on earth are transformed simultaneously.

The book of First Thessalonians does not teach a clandestine return and rapture but says, "he (Jesus) shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God" (1 Thess. 4:16). This is one of the noisiest verses in the Bible! The verse says, "the dead in Christ shall rise first."

Verse 17 says the saved of earth shall, with the sainted dead, be caught up "in the clouds to meet the Lord in the air: and so shall we ever be with the Lord." The word "so," most people know, is an adverb of manner, and means "in this manner," that is, "in the air," shall we ever be with the Lord.

The rapture notion teaches, instead, that only the living righteous will be caught up in the air to be with Christ for seven years. Then they are to return to earth with him in The Revelation.

The advocates of a covert coming of Christ and the rapture say the Bible pictures the final coming Jesus as like a thief. So, they think, he will sneak in and snatch the saved from the earth secretly, like a thief doing his work.

The Bible does not teach the act of Christ's coming to be as a thief, but says "the day" comes like a thief in the night (1 Thess. 5:2). This does not teach that Christ will be sneaking in and out but shows we cannot know when Christ is coming.

# CONTRARY TO BIBLICAL TEACHING

Many things in this fanciful doctrine contradict Bible truth! The word “rapture” is not Biblical. Hal Lindsey says it is not in the Bible and tells us not to look for It (The Late Great Planet Earth, page 126). Consider some discrepancies of this doctrine with God’s revealed truth.

## First Discrepancy

The idea that the saved are to be taken from the world, while the lost remain, violates Bible teaching. The parable of the tares (Matt. 13:24-30; Matt. 13:38-43) disproves this notion. The wheat and the tares grow together “until the harvest” (13:30). Jesus tells us “the good seed are the children of the kingdom” and “the tares are the children of the wicked one” (13:38). “The harvest is the end of the world” (13:39). The sacred scriptures say the good and the bad will “grow together” until the “end of the world.” In the final harvest the householder will command, “Gather ye together first the tares, and bind them in the bundles to burn them: but gather the wheat into my barn” (verse 30). Jesus’ interpretation of the parable says, “The Son of man shall send forth his angles, and they shall gather out of his kingdom all things that offend, and them which do iniquity; and shall cast them into a furnace of fire: there shall be wailing and gnashing of teeth. Then shall the righteous shine forth as the sun” (verses 41-43). The impress of the passage is a simultaneous judgment of the saved and the lost. The parable says the lost are to be cast into the fires of hell at the same time the saved go to their heavenly mansions.

## Second Discrepancy

Dispensational millenarians teach separate resurrections of the good and evil. According to them, the transformed

righteous of earth are swept away to a seven-year ecstasy. After the seven years, the sainted dead are resurrected to take part in a victorious 1,000 year earthly kingdom. After this, the wicked are resurrected. This makes different resurrections separated by at least 1,000 years.

Jesus said, "Marvel not at this: for the hour is coming, in the which all that are in the graves shall hear his voice, And shall come forth; they that have done good, unto the resurrection of life; and they that have done evil, unto the resurrection of damnation" (John 5:28-29).

Some try to dodge the force of this by saying that "all" simply refers to the saved. Jesus takes care of this quibble—"they that have done good, unto the resurrection of life; and they that have done evil, unto the resurrection of damnation." The ransomed and the damned are raised the same hour.

## **Third Discrepancy**

The rapture theory demands a secret coming of Christ. In discussing the destruction of Jerusalem, Jesus told his disciples not to believe it if some said, "Lo, here is Christ, or there" (Matt. 24:23-26). Jesus explained, "For as the lightening cometh out of the east, and shineth even unto the west; so shall also the coming of the Son of man be" (Matt. 24:27).

Just as all see the flash of lightening, so Christ's ultimate coming will be open and public. It will not be an event so secret that most of mankind will not even realize Christ has returned until many hours afterward. Acts 1:11 tells us, "This same Jesus, which is taken up from you into heaven, shall so come in like manner as ye have seen him go into heaven." When he comes again, "every eye shall see him" (Rev. 1:7).

## **Fourth Discrepancy**

The rapture speculation of millennial dispensationalists demands two future, literal returns of Christ. They call one return “the rapture” and the other return “the revelation.” Jesus promised, “I will come again” (John 14:3). He did not say, “I will come again and again.” Hebrews 9:28 tells us that “unto them that look for him shall he appear the second time without sin unto salvation.” A third literal coming of Jesus is not promised in the holy scripture.

Dispensationalists downplay what the Bible says about a second literal coming by calling it the first and second “phase” of his second coming. This does not remove the fact they teach he is coming two more times, with seven years between his second and third coming. The Bible teaches one, still future, literal coming of Christ!

## **Fifth Discrepancy**

A seven-year period of great tribulation on earth triggered by the second, literal coming of Jesus is not in the Bible. Matthew 24:21 mentions “great tribulation” at the destruction of Jerusalem – not after this age and the destruction of the earth.

The great tribulation of Matthew 24 cannot refer to Jesus’ last coming. The passage tells his followers not to return to their houses for possessions and speaks of the difficulty of being pregnant or nursing a baby and of the inconvenience of fleeing during the winter or on the Sabbath, all of which is meaningless, unless he is speaking of Jerusalem’s destruction, and not of his second, final coming. If Jesus is coming again to steal, like a thief, the good folk from the earth, it is pointless to tell them not to pack their clothes nor urge them to pray nor to have babies, nor that it is winter, nor the Sabbath day when he comes to zing them into rhapsody.

Revelation 7:14 speaks of victorious saints who suffered “great tribulation” on earth, who are rewarded by the Lord in heaven. There is no passage in all the Bible that speaks of a great tribulation after the Christian age. The Bible speaks instead of great comfort for the redeemed at the end of this period.

## **Sixth Discrepancy**

The antichrist concept of millennialism is foreign to the scriptures. Antichrist simply means a person who is against Christ. The term is never used in the Bible to designate a leader of the forces of evil at the end of time.

1 John 2:18 helps answer this false emphasis. John said, “even now are many antichrists.” The antichrists of John’s day disprove the claim that one antichrist will appear after this age.

A list of those identified as the antichrist is amusing – Napoleon, Wilhelm, Hitler, Mussolini, Stalin, Henry Kissinger, and Ronald Reagan. Soon someone will add Saddam Hussein to the roll. The prophets for dispensationalism are obviously wide of the mark, but that does not seem to bother their followers. They commonly ignore Deuteronomy 18:22! The prophets of the rapture, who teach lies, are the tail (Isa. 9:15)

## **Seventh Discrepancy**

The battle of Armageddon, according to dispensational millennialists, is a war between the forces of the antichrist and those of Jesus at his literal, second coming. Revelation 16:14 mentions a “battle” and Revelation 16:16 mentions a place called “Armageddon.” Neither the antichrist nor Christ’s last coming is mentioned in this passage.

Pre-millennialists say prophetic statements should be accepted

in an unqualified sense. The battle of Armageddon is therefore a verbatim, carnal warfare. Some claim the carnage will be so great blood will really flow to the depth of the horse's bits – horses will be swimming in human blood.

Will they accept as literal “three unclean spirits like frogs” coming “out of the mouth of the dragon” to gather the kings to battle? The war of Revelation 16 is no more literal than is the instigator a literal frog who comes out of the mouth of a literal dragon.

## **Eighth Discrepancy**

Advocates of the rapture say the earthly phase of the kingdom of heaven is to begin when Christ comes a second time unto salvation. The bible says the earthly phase of the kingdom of God now exists and will end when Jesus appears a final time.

The kingdom of heaven, which John the Baptist said was at hand, began on the Pentecost of Acts 2, during the Roman empire as foretold in Daniel 2:44. First century saints were in it (Col. 1:13-14; Heb. 12:28). At Jesus' last coming he will deliver an already established kingdom to God the Father (1 Cor. 15:23-25).

## **Ninth Discrepancy**

Dispensationalists list as many as seven separate days of judgment. All such false teachers list at least three days of judgment – one at the claimed rapture of the saints, another for the nations after the assumed seven-year tribulation, and a third at the end of the so-called millennium.

The Bible teaches one day of judgment. Near the end of the gospel of Matthew we read of the day of judgment at least four times (Matt. 10:15; Matt. 11:22-24; Matt. 12:36), and “judgment” (singular) at least two more times (Matt.

12:41-42). "He hath appointed a day in which he will judge the world" (Acts 17:31). The idea of various days of judgment for various groups of people is alien to the Bible.

"As it is appointed unto men once to die, but after this the judgment: So Christ was once offered to bear the sins of many; and unto them that look for him shall he appear the second time without sin unto salvation" (Heb. 9:27-28).

# Miracles

Do miracles occur today? If they do, who performs them? Perhaps most important, what is a miracle?

Most of us believe that God performs "miracles" daily as we consider the worlds in orbit and development of a tiny seed into a great plant. But this usage of the word "miracle" means "an unfathomable wonder" not a direct sign from God given as some special confirmation of His will. Our bodies are a miraculous creation! In this sense God continues miracles, and "miracles" is used, in this sense, by many writers in a poetic way. "To me, every hour of the day and night is an unspeakable, perfect miracle" (Walt Whitman).

A speaker recently declared that he believed in miracles. He told of his heart transplant and that his heart stopped beating twice and that the doctors and nurses started it again with electrical shocks. He said that he had died twice and

came back to life.

This event was, understandably, a miracle to the speaker. By this definition, nearly everyone believes in miracles. But his wonderful experience is in no way comparable to the miracles of the New Testament. Those miracles were signs of a special sort which God used to confirm the inspired word. Marvelous medical advancements are different; they do not defy explanation, as do Biblical miracles, but are merely wonderful examples of human achievement.

Biblical miracles were real miracles. When Christ healed the sick, raised the dead, and gave sight to the blind, He never declared, "I will perform this miracle provided you go to the hospital and let the surgeons operate on you." His miracles did not depend, even in part on the skill of earthly physicians or technology.

Miracles, such as the restarting of a stopped heart, do depend upon man and his skills. Such "miracles" do not have the same force upon those who witness them. When Jesus performed a miracle, no one could doubt that God had intervened in the natural world. God may, or may not have intervened in the heart transplant case, but doubt exists. Jesus' signs left no doubt, to the observer, that God had suspended natural laws to do His will.

One denominational Houston preacher who has a large following declares that he believes miracles happen today in the same way as Christ and the Apostles performed them. He says that he prayed for his young daughter, and she was healed. The daughter is now grown, and a few weeks ago, was opening the mail for him when a bomb went off in her lap. Does he rush in and pray that God will heal her? He claims his prayer was answered before. Does he rely on a miracle now? No sir! He rushed her to the emergency hospital and implored the surgeons to do their work. If God miraculously heals today, why not pray for her right there in the office and let God do the

healing, without benefit of surgeon or nurse?

Would this sort of "miracle," say the rushing of Bartimaeus to the emergency room in Jericho, have confirmed Christ or his word? Certainly not! Christ did not perform miracles in this fashion.

God is all powerful and one day will perform the miracle of miracles by resurrecting all that are in the grave (John 5:28-29). He will also instantaneously change those then living (1 Cor. 15:51-52). But today He does not give the spiritual gifts of healing, tongues, prophecy, miraculous knowledge or any of the other gifts mentioned in 1 Cor. 12:6-10. God Himself told us that miraculous gifts would cease. "Charity never faileth: but whether there be prophecies, they shall fail; whether there be tongues, they shall cease; whether there be knowledge, it shall vanish away. For we know in part, and we prophesy in part, But when that which is perfect is come, then that which is in part shall be done away" (1 Cor. 13:8-10).

He tells us plainly that faith, hope and love (these three shall abide or continue) not the eleven gifts which included the miraculous and healing gifts of the twelfth chapter. Only three were to abide! "And now abideth faith, hope, love, these three; but the greatest of these is love" (1 Cor. 13:13).

What is that which is perfect? David declared in Psalm 19:7, "The law of the Lord is perfect, converting the soul." James calls the New Testament "the perfect law of liberty" (James 1:25). So when the law of God was completed (made perfect), then miraculous gifts ceased. God said they would fail, cease, vanish away! I believe God rather than Oral Roberts, Pat Robinson or John Osteen. God no longer performs miraculous feats such as raising the dead, walking on water, the gift of prophecy, healing or speaking in tongues.

We believe in prayer, but we do not believe prayer will cause

God to grant us the miracle-working power that He gave in the first century. Some people believe that God has to perform a miracle for prayer to be answered. That position is not supported by scripture. God's hands are not tied, nor his power limited. God does move in our world. God provides many things in answer to prayer. Prayer accomplishes much, but God has not promised miracles in our age of the same kind that He performed through Christ and the inspired apostles.

Consider Heb 2:3-4:

*"How shall we escape, if we neglect so great salvation; which at the first began to be spoken by the Lord, and was confirmed unto us by them that heard him; God also bearing them witness, both with signs and wonders, and divers miracles, and gifts of the Holy Ghost, according to His own will?"*

Consider also Mark 16:17 and Mark 16:20:

*"And these signs shall follow them that believe; In my name shall they cast out devils; they shall speak with new tongues; They shall take up serpents; And if they drink any deadly thing, it shall not hurt them; they shall lay hands on the sick, and they shall recover." Did this occur? Read verse 20. "And they went forth, and preached everywhere, the Lord working with them, and confirming the word with signs following."*

The miracles or signs described in the preceding passages were to confirm the word. In that time without a written New Testament early Christians could know that God inspired certain messages because God confirmed the word by His miracles. He has confirmed His word: He does not need to continue the confirmation.

"Wherefore he saith, When he ascended on high, he led

captivity captive, and gave gifts unto men... And he gave some Apostles; and some prophets; and some, evangelists; and some, pastors and teachers; For the perfecting of the saints, for the work of the ministry, for the edifying of the body of Christ: Till we all come in the unity of the faith, and the knowledge of the Son of God unto a perfect man... That we henceforth be no more children, tossed to and fro, and carried about with every wind of doctrine..." The first century church needed all these miraculously inspired people as they had no written New Testament then. Later the word was committed to writing. Obviously we no longer have Apostles or Prophets, nor do we have inspired evangelists, pastors or teachers. The inspired people were to continue "Till we all come in the unity of the Faith" (Eph 4:8).

We now have that faith, in the unified form, in the New Testament. Jude declared that we should "earnestly contend for the faith" (Jude 3). This is not our personal faith, but the system of faith which had been revealed in God's Holy Word. Miraculously endowed gifts were to last "till we all come in the unity of the faith, and of the knowledge of the Son of God..." (Eph. 4:8). This unity of the faith and knowledge of the Son of God was completed, made perfect, when the last word of inspiration was written.

Now instead of all these miraculously endowed individuals, we have the "perfect law of liberty" completely given to mankind. God said supernatural things were to cease (1 Cor. 13:8), so His word being true, we have none of these today.
